Under the plan ANDERSON FUEL will replace, repair with new or re-manufactured parts (as indicated on the diagram), those parts which may become defective through normal use. Parts not covered will be replaced on a time and material basis and are guaranteed for one year.

Our obligation to supply heating oil parts is based on availability through normal source of supply.

The plan is subject to inspection and acceptance by ANDERSON FUEL up to and including the first visit by a service technician.

In order for ANDERSON FUEL to provide the best possible service, the customer is responsible for maintaining adequate ventilation necessary for combustion and access to the oil-fired heating appliance, fuel supply tank(s), and associated areas.

Renewal: The Plan will automatically renew on its anniversary date unless terminated in writing by either party 10 days prior to expiration.

Please call the Office to schedule your yearly maintenance.

The Plan Does NOT Cover:

- Parts or labor for damage caused by fire, flood, wind, water, accidents, acts of war, terrorism, strike, freezing, generators, power outages/spikes, tampering, vandalism, vacancy,* customer negligence, or acts of God.
- Parts or labor through which the heating medium: water, air or steam is in contact with or passes through except where noted.
 Additional exclusions include:
- Adjusting thermostats/batteries, turning on switches, replacing fuses or resetting circuit breakers.
- Modernization of the boiler, burner, furnace, and/or controls.
- Damages to parts and/or property due to customer negligence of vacant or unattended property.*
- Modifications to the heating appliance and related parts necessary to meet state or federal code requirements.
- Purging air from Heating Systems/Zones
- · Air-conditioning systems or associated parts.
- Electronic relay circuit boards.
- Electronically Commutated Motors (ECM).
- Oil tanks/tank legs, oil lines, oil de-aerators, and any part in conjunction with said equipment.
- Domestic hot water tanks/tankless coils and components.
- Low Water Cut-offs, Circulating Pumps, Zone Valves.
- * If leaving property unattended due to vacation, moving, work, etc., please have a third party check on the property to verify that the heat is working, <u>especially</u> during freezing temperatures.
